

The Parent Link Newsletter Terms and Conditions

Upon subscribing, I agree to accept the Terms and Conditions of The Parent Link Newsletter.

The Parent Link will provide each registered user ("Member") with access to an account to personalize their newsletter to the extent available in each edition. By registering as a Member, you agree to use the Newsletter in a manner consistent with all applicable laws and regulations and in accordance with the Terms & Conditions set out below. The Parent Link reserves the right to impose additional terms in respect of any Member's subscription, such additional terms shall be posted on the Site.

1. Price and Payment. A subscription is considered to be twelve (12) consecutive months from the date of subscribing and consists of one (1) issue each month. The newsletter is delivered to members through their on-line account. Basic support is provided to members by email and telephone only.

Payment for the Newsletter can be made through a valid credit card or by check. Payment is due in full at the time the Member subscribes. To remain a Member in good standing, checks must be received no later than thirty (30) days from the date the Member subscribes. For accounts not meeting these criteria, activity will be suspended until payment is made.

2. Cancellation Policy. A full refund will be provided to a member who cancels within 30 days of subscribing. No refunds will be available for cancellations after that period of time. Cancellation requests should be emailed to mary@theparentlink.com.

3. Trial Subscription During Trial Period. At any time during a trial subscription period, a Member has the option to end their trial and begin subscribing to the service. If a Member chooses not to subscribe at the end of the trial period, there is no charge or further obligation to the Member.

4. Rules for Online Conduct. The Member agrees to ensure that all personalized content has been reviewed by the Member before it is available to recipients.

5. Privacy. The Parent Link will keep confidential any information it holds about a Member, which is of a confidential nature and not supplied for inclusion on the Newsletter.

6. Copyrighted Material. All material on the Site, including, without limitation, text, photos, graphics are protected by copyright laws, both as individual works and as a collection. Members, in good standing, are granted use of the newsletter to distribute to their members through the church's website, by email or through print media.

The Parent Link, Parent Link staff and third-party content providers make no guarantee of the accuracy, correctness or completeness of any information on the site and are not responsible for any errors or omissions arising from the use of such information; any failures, delays, or interruptions in the delivery of any content or services contained within the Site; or any losses or damages arising from the use of the content or services provided by the Site.

8. On no account shall The Parent Link have any liability to the Member for consequential, special, economic or indirect loss, for loss of savings or goodwill or for loss of revenue.
